#### Cubic, Inc. (via teleconference)

Amber and Victoria of Cubic reviewed the Q1 2018 Results with the members. The report included but was no limited to the following:

- Social Media Insights: Facebook Insights, Facebook and Instagram
- Paid Social Results Facebook Advertising (Audience Targeting, Winter Page Promotion, Facebook and Instagram Advertising)

It was noted that the charts for the metric build in the Acquisition Overview are reversed and do not coincide with the year in the heading which will be corrected. (A copy of said Report is on file.)

## **UPDATES**

- Suzanne Holt reported that a Food and Beverage event was held at the Falcon, which included approximately 100 food and beverage manufacturers. A major concern of the group was distribution; therefore arrangements were made to have a well-known distribution expert from Massachusetts address the group that evening. As a result, Jason Geib, from ImmuneSchein will now be leading a task force with other people to work together toward a solution.
- Three community economic development events have been completed, which included the Towns of Saugerties, Esopus and New Paltz with good turnouts. Another one is scheduled on June 19<sup>th</sup> for Shandaken, Hardenburgh and Denning. Similar events are slated for the future for the Town of Ulster and the Town of Woodstock.

- o A Broadband event is tentatively scheduled for May 15<sup>th</sup>.
- The film event for May 5<sup>th</sup> at the Maritime Museum is sold out and registration has been closed.
  Due to the extreme interest, it was decided to have an unofficial after party at Ole Savannah's.
  The goal for this event is networking and collaboration to produce films in Ulster County.
- A Green Business Challenge is being planned; however, the Environmental Department is taking the lead. Manna Jo Green and her committee are creating a challenge whereby businesses can have a green infrastructure investment. The event will kick off at a breakfast meeting in June.
- On behalf of UCEDA, Luminary has negotiated a Woodstock Film Festival Sponsorship for \$10,000.00. During the review of the sponsorship proposal with the members, Ms. Holt discovered that the copy which was included in the meeting packet had since been revised and no longer includes 4 passes. It was modified to provide for 2 passes to all networking parties at the festival (instead of 4 passes) and the addition of an information table with a UCEDA member present in Hospitality Lounge. The revised agreement will be forwarded to the members after the meeting. (Copies of the agreements are on file.)
- Ms. Holt stated that the Jump Start Program campaign has resulted in one application so far and many phone calls. Flyers are being hung in Ellenville.
- Two of the façade programs have been paid.
- The PCT training was a huge success. Current discussions are being held regarding a possible pulmonary training in the fall.

Suzanne Holt added that she and her staff have been working with Grand Central Tech to start a summer program here. As part of this program, there will also be an internship available for SUNY New Paltz and SUNY Ulster County Community College. Ms. Holt stated that there is a Sponsorship Agreement in the packet for the Board's approval today concerning the same.

A brief discussion ensued.
