Technical Overview

Portfol Cloud is an Infrastructure as a Service offering. Your Portfol data and software is hosted on Microsoft Azure. Uptime, maintenance, updates, and backups are managed by Portfol support.

User Access Requirements

For users to access Portfol Cloud there are a few requirements:

- Microsoft 365 License Business Premium, E3, or E5 Portfol requires one of these licenses as
 we leverage "shared activation" in our Azure Remote App environment. <u>Up to 10 of these</u>
 licenses can be secured for free as a nonprofit organization.
- OneDrive / Sharepoint To sync documents from the Portfol Cloud Environment to local
 workstations we use document sync services like OneDrive and Sharepoint. We have used
 Dropbox and Google Drive if requested by the client.
- Microsoft Remote Desktop Client Portfol will be deployed to users via a Remote App. This
 allows Portfol to not only be run on Windows computers, but MacOS and iOS devices, too.

Security

All data is encrypted at rest and in transit.

User access to the Remote App requires a Portfol.net account (<u>username@companyname.portfol.net</u>). These accounts require complex passwords and MFA.

Backups

Backups are conducted daily and maintained for 30 days. If there are additional backup requirements we can discuss.
