I. Approval of Minutes: A motion was made by Mr. Graham to approve the March 2013 minutes. The motion was seconded by Dr. Tack and unanimously approved.

II. New Member: Dr. Tack introduced Elizabeth Kelly, RN and owner of Burgevin's Flowers as the new Board of Health member. Her term expires February 28, 2018.

III. Agency Reports:

- a. <u>Commissioner's Update:</u>
 Dr. Smith reported on the following:
 - Community Health Assessment Stakeholder's Summit: The Community Health Assessment summit scheduled for March 26, 2013 has been rescheduled for May 21, 2013.
- b. <u>Medical Examiner:</u> A summary sheet of the March activity was distributed and reviewed (see attached).
- c. Patient Services:
 - Ms. Veytia reported on the following:
 - Mass Gathering: Continues to work with Environmental Health Services to create the Ulster County Mass Gathering Protocol. Key DOH staff have begun meeting to review the Dutchess County template and adjust it to fit Ulster County needs. A time/service study will need to be conducted as first steps in establishing a permitting fee for Mass Gathering events. Dr. Smith has begun querying neighboring counties to inquire about their protocol, successes, issues, fees and costs.
- d. Environmental Health Report:
 - New Environmental Health Director: Dr. Smith introduced Shelley Mertens as the new Director of Environmental Health Services. Shelley has served in the capacity as Senior Public Health Engineer for the Department since 6/2006.

- Food Service Permits: All food facility renewal permits have been processed with a decrease in late submissions and enforcement hearings.
- Legionella Update:
 - o Ten Broeck Commons has installed their UV System. The first round of testing was clean. At second round of testing will be done in about three weeks.
 - o Per a follow-up conversation Ms. Mertens with Governor Clinton, all is well with their system.
