#### II. Agency Reports:

- a. Reappointment of the Commissioner of Health and Mental Health: The Board was informed of the County Executive's reappointment of Dr. Smith for a second six (6) year term as Commissioner of Health and Mental. Dr. Smith's reappointment is subject to confirmation by the Ulster County Legislature, and the State Department of Health.
- b. Commissioner's Report: Dr. Smith reported on the following:
  - Medical Examiner Stats: The Medical Examiner stats were distributed to the Board for review (see attached).
  - Ulster County Opioid Prevention Task Force: The County Executive has tasked the Department of Health to do a thorough review of their substance use prevention strategy in order to strengthen collective efforts to address the ongoing opioid crisis. A task force is being established with as many community stakeholders as possible to complete this review. The Task Force will be an action oriented group which will focus on reducing supply, reducing demand, identifying gaps, looking at evidence-based practices and identifying those efforts which are already being done. The first Task Force meeting is scheduled for May 24, 2018 and an invitation letter was sent to community partners encouraging their participation (see attached).
  - Flu Stats: A copy of the most current flu stats were distributed to the Board for review (see attached).
  - Point of Dispensing Drill: As part of the Preparedness Program's grant deliverables, the Program is obligated to conduct a Point of Dispensing (POD) drill. This exercise is scheduled to held on May 1, 2018 at the SUNY Ulster Kingston campus. The Program is currently in the process of recruiting volunteers (see attached).

III. Next Meeting: The next meeting is scheduled for May 14 , 2018, 6:30 PM at the Golden Hill Office Building.

**Urgent Public Health Message** 

#### **Dear Community Partner:**

Since County Executive Mike Hein took office in 2009, Ulster County has become much more focused on health outcomes and has made great progress in the Robert Wood Johnson National Health Rankings. Unfortunately, even with this progress in our County, heroin and other opiate drug abuse is negatively impacting us. It is a serious and ongoing public health crisis, and is one that demands that we have a coordinated and broad based community response.

As one of our 2018 priorities the County Executive has directed a thorough review of our comprehensive substance use prevention strategy, with a focus on opioids, in order to better coordinate, integrate, and further strengthen our collective efforts.

In order to accomplish this review and the development of a plan of action, I am inviting you and other community members to join a new Ulster County Opioid Prevention Task Force. This Task Force will report directly to me as the Ulster County Commissioner of Health and Mental Health. It will be tasked with examining all relevant data, research, existing programs and practices and identify barriers and obstacles to success. In addition, we will strive to identify best practices that could be implemented in Ulster County.

The goal of the Task Force will be to recommend an **Action Plan** designed to reduce the suffering and tragedy of substance abuse in our community and to enhance the awareness and education necessary to prevent it from occurring in the first place.

Our first informational meeting will be held on Thursday, May 24th, from 1 to 4 PM, at the Ulster County Department of Health and Mental Health, 239 Golden Hill Lane, Kingston, NY 12401. Additional

details will be discussed at that time. If you are able to participate, please RSVP by email to UCOpioidTaskForce@gmail.com, no later than the close of business on Thursday, May 3<sup>rd</sup>.
