1. Approval of Minutes: The March minutes were tabled until the May meeting due to a lack of a quorum.

- 2. Board Members: Dr. Woodley and Dr. Smith discussed with the Board their concern with Board Member attendance to meetings and the importance of their participation and input. It was agreed that all Board Members will be contacted via phone or letter to inquire about their attendance to future meetings.
- 3. Commissioner's Update: Dr. Smith reported on the following:
  - Camp Season: No update
  - UC Buildings Reopening: To date there is no reopening guidance. Dr. Smith presumes the reopening date will be June 1,2021. A confirmed date and reopening guidance are forthcoming.
  - New Staff Introduction:
    - o <u>Tim Rose</u> has been hired as the new Environmental Health Director. Mr. Rose had work as the Director of Ulster County Resource Recovery Agency and had previously worked for the NYS Regional office 1995-2004. He is a licensed Engineer.
    - o <u>Cynthia Pomeranz</u> has been hired as a Supervising Public Health Nurse within the Patient Services Division. Mrs. Pomeranz has years of experience working as a Public Health Nurse in Communicable Disease Unit of Patient Services.
  - Vacancies: A few pivotal positions within the Department are needing to be filled; Public Health Nurse(PHN) and Public Health Engineer(PHE). A few applications have been received for the PHN position however there have not been any received for the PHE. Dr. Smith will reach out to SUNY Ulster and other schools to

- post the positions and they will also be posted on Indeed.
- Opioid Update: Mr. Martello shared the most recent opioid data (see attached). There is a lot of prevention in place to assist in minimizing this epidemic. Seeing an increase in numbers which could be the result of COVID creating isolation and increased financial concerns among individuals.

### • COVID Update:

- o Dr. Smith discussed the lasted numbers for the COVID data (see attached). The County is vaccinating as many individuals as they can however, the percentage of individuals receiving the vaccination is lower than desired. Wutan strain has decreased. Now seeing an increase in the UK strain cases. There is a daily average of 55 COVID cases. The Hudson Valley Region has a higher number of cases than other NYS areas. Ulster County has established PODs at the Best Buy location, select churches within the community and pop-up PODS have been established throughout the County, as well as, "at home" vaccination for housebound individuals. There has been of help from sister departments, surrounding counties and through the use of contract nurses. There have been reports of individuals on vaccinated individuals still testing positive for COVID. The vaccine is not a guarantee an individual will not get COVID but will lessen an individual's likelihood of getting a severe case of COVID.
