- 1. Approval of Minutes: Approval of the July 2021 meeting was approved by Ms. Rogan, seconded by Dr. Carena and unanimously approved.
- 3.Commissioner's Update: Dr. Smith reported on the following:
  - COVID Overview:
    - Reviewed the most recent COVID numbers (see attached). Seeing a fair number of individuals tested each day. There has been an increase in new positive cases. The 7-day rolling average is over 6.6%. Cases continue to be scattered throughout the County in a variety of places. COVID is showing no signs of ending. The County has continued to offer vaccinations at the Best Buy site in the Hudson Valley Mall on Fridays, mostly Pfizer and Moderna.
    - Still in the process of working with the schools to determine needs, nurses, kits, etc. The school needs are more than originally thought. DOH would like a better breakdown of their plan for testing.
  - Medical Examiner (ME): The entire ME team is scheduled to meet on 9/21 to address issues. County is working through renewing the ME services contract with Westchester Medical Center. The current Forensic Pathologist, Dr. Charles Catanese, is talking about retiring and there has been mention of the ME's retiring. The ME stats report was shared (see attached).
  - Environmental Update:

- Currently one fulltime Engineer and one Parttime Assistant Engineer are reviewing all site plans received by the Department. This is inadequate to meet the demands as there has been an increase of regulatory demands with more to come.
- Rainfall always results in an overflow of the Kingston Water Treatment system into the Rondout which impacts areas such as the Kingston Point Beach. Ms. Rogan voiced concern about individuals still using the beach when it is closed. Dr. Smith reminded the Board that it is the job of Law Enforcement to enforce closures.

#### 4. Board Updates:

- Behavioral Health Beds/ Westchester Medical: The Board discussed how the letter should insist that the beds return to Ulster and the letter should be sent to Westchester and to OMH, OASAS, NYSDOH, The Public Health and Planning Council and copied to the County Executive and the Community Services Board. The question was posed asking if Westchester could be forced to move the beds back. Individuals are impacted greatly. There is a loss of continuity of care, they are removed from their support systems and the providers they follow-up with when discharged. There has also been concerns about the recent reduction of hospital staff. There is chatter of hospital staff not being happy and many are going elsewhere.50 out of 117 ME cases are behavioral health related. A motion was made by Ms. Rogan to proceed with the letter of protest of the elimination of Behavioral Health and SUD inpatient beds at Health Alliance in conjunction with the Community Serves Board. The motion was seconded by Dr. Carena and unanimously approved.
- Board Vacancies: There are currently two vacancies. Any potential candidates names should be referred to Dr. Smith's office.
- **6. Adjournment:** Ms. Turco made a motion to adjourn, seconded by Dr. Carena and unanimously approved.
- 7. Next Meeting: Scheduled for Monday, October 18, 2021 at 6:30 PM, at the Department of Health 239 Golden Hill Lane.
