

**AMENDMENT No. 1 TO  
PROFESSIONAL SERVICES**

**ELLENVILLE MILLION JUMP START COMPETITION**

This Amendment No. 1 (“Amendment No. 1”) is effective as of June 4, 2019 (the “Amendment Effective Date”) and entered into by and between the **ULSTER COUNTY ECONOMIC DEVELOPMENT ALLIANCE, INC.**, a local development corporation formed under the laws of the State of New York, with offices at 244 Fair Street, Kingston, New York 12401 (the “**UCEDA**”), and **CARMEN’S SABOR LATINO, INC.**, a corporation duly organized under the laws of the State of New York, having its principal office at 1 Clinton Street, Napanoch, New York 12458 (the “**Firm**”), (each, a “Party,” together, the “Parties”).

**RECITALS**

**WHEREAS**, UCEDA and the Firm entered into an Agreement wherein the Firm agreed to contract with the UCEDA to make the investments and create jobs as described in the Firm’s application; (hereinafter referred to as the “Agreement”); and

**WHEREAS**, UCEDA and the Firm have agreed to amend the Agreement to extend the Program by six (6) months to complete the necessary work.

**NOW, THEREFORE**, in consideration of the mutual promises set forth herein, the Parties agree as follows:

**AGREEMENT**

1. **ARTICLE 2 – TERM OF AGREEMENT.** Article 2 of the Agreement is hereby deleted in its entirety and is amended and restated to read as follow:

**“ARTICLE 2 – TERM OF AGREEMENT**

The Firm agrees to perform the Services **beginning September 5, 2018 and ending December 31, 2019.”**

2. Capitalized terms used but not defined herein shall have the meanings set forth in the Agreement.
4. Except as expressly set forth herein, the terms and conditions of the Agreement shall continue in full force and effect.
5. In the event of a conflict between the Agreement and this Amendment No. 1, the terms and conditions of this Amendment No. 1 shall control.
