

## **AMENDMENT NO. 1 TO AGREEMENT ESCAPEMAKER.COM, INC.**

This Amendment No. 1 (“Amendment No. 1”) is effective as of December 23, 2021 (the “Amendment Effective Date”) and entered into by and between the **ULSTER COUNTY ECONOMIC DEVELOPMENT ALLIANCE, INC.**, a local development corporation formed under the laws of the State of New York, with offices at 244 Fair Street, Kingston, New York 12401 (the “**UCEDA**”), and **ESCAPEMAKER.COM, INC.**, a Delaware business corporation with offices at 442 Glenerie Boulevard, Saugerties, New York 12477 (the “**Contractor**”) (each, a “Party;” together, the “Parties”).

### **RECITALS**

**WHEREAS**, the Parties entered into an agreement effective December 23, 2021 for assistance through the Ulster County CARES Program (the “Agreement”); and

**WHEREAS**, the Contractor has requested a change to the allocation of funding in certain categories of the Agreement; and

**WHEREAS**, the Parties have agreed to revise the Agreement as further detailed below.

**NOW, THEREFORE**, in consideration of the mutual promises set forth herein, the Parties agree as follows:

### **AGREEMENT**

1. Schedule B. Paragraph 3 of Schedule B of the Agreement is hereby deleted in its entirety and is amended and restated to read as follows:

The Contractor shall expend the funds it receives through the Ulster County CARES Program in accordance with the amounts and categories listed herein, as follows:

a. Furniture /Fixtures:	N/A
b. Equipment (excludes construction-related projects):	N/A
c. Personal Protective Equipment:	N/A
d. Inventory:	N/A
e. Operating Expenses:	\$9,250.00
f. Payroll:	\$20,750.00
g. Other (must be pre-approved by UCEDA):	N/A

3. Except as expressly set forth herein, the terms and conditions of the Agreement shall continue in full force and effect.
4. In the event of a conflict between the Agreement and this Amendment No. 1, the terms and conditions of this Amendment No. 1 shall control.
