#### Presentation of 2022 Audit

- Discussion: Herb Litts informed the Board that earlier today, the Audit Committee convened to review updated materials for the 2022 audit and tax return. He then asked Amanda LaValle to summarize the updates. Amanda explained that since the previously presented audit, UHY was informed of a credit given to National Resources toward utilities accrued in 2022. This credit was given as a result of storage rents income to UCEDA. UCEDA paid the full amount of the utilities due in full to the County and therefore the credit was used toward the taxable income of UCEDA. The revised amount of tax due was therefore decreased from a little over \$19,000.00 to \$11,863.00.
