### Presentation of CARES 1, CARES 2, CARES 2.1 Report Update

## Discussion:

Samantha Liotta presented an update of CARES 1 & CARES 2 as per Board request (item 2 in the packet). CARES 1 disbursements totaled \$947,057.00. Total amount recaptured is \$15,000.00 due to EZ Fast Printing non-compliance of reporting to NYS. There were 14 rounds of disbursement between March 23, 2022 to February 22, 2023. Businesses assisted totaled 33. Currently working on final annual performance report due to NYS HCR now that the recapture payment has been finalized. This report will be submitted by November 30, 2023. Working with UC Comptroller's Office regarding audit request of the program. Materials have been submitted.

CARES 2 total amount awarded has been revised to reflect those who were determined by UC Comptroller's to be eligible. This matches the resolution passed by UC Legislature. Total amount awarded is approximately \$538,000. Amount disbursed to date is \$369,000. One pending, 21 businesses included. \$123,000.00 remains to be awarded.

CARES 2.1 awarded \$395,000. Total disbursed to date is about \$240,000.00. One pending disbursement. Disbursement to 17 businesses began September 28, 2023. Comptroller audit is complete. Extensions are expected.

### **Dixon Roadside Update**
