## Solarize Ulster 2.0

The new Solarize Ulster RFP was released last week and proposals are expected to be returned to the county by June 23<sup>rd</sup>. The purpose of this RFP is to obtain competitive proposals from community distributed generation (CDG) subscription providers to participate in a joint marketing campaign with the Ulster County government and provide services to Ulster County residents who subscribe through the campaign.

# Goals:

The goals of this campaign include:

- Foster public understanding and trust in the community distributed generation (CDG) model.
- Provide transparent pricing and agreement terms to County residents.
- Support the development of locally sited, renewable electricity generation sites as part of Executive Order #1 of 2023.
- Enroll a minimum number of Ulster County households to CDG projects (goal to be determined upon consultation with the selected Providers).
- This campaign will run for 1 year. (Last campaign was only 18 weeks)
- Will require consolidated billing.
