## **OFFICER REPORTS**

## President / CEO Report

## First Quarter Report 2025

Kevin Lynch, UCEDA President gave an overview of the first quarter of 2025. Status updates were provided on items including UCEDA budget, professional services provided by Bonadio & Co., Strategic Planning, Policies and Procedures, Ulster County RLF, iPark and long- and short-term planning. Kevin mentioned that the Sole Member and Annual Meeting will be held on May 19, 2025. Kevin also discussed plans for moving forward with developing partnerships and collaborations for County development and website development.

#### iPark/National Resources Update

Kevin gave a reminder that there is now an executed lease termination agreement. Ward Todd asked what the status of communication with iPark has been. Kevin Lynch stated that he has spoken with the CFO from National Resources about outstanding and reimbursable attorney fee invoices. UCEDA has invoiced National Resources for these fees. Discussion was held as to where National Resources stands as far as progress on site development and getting tenants into the property. Herb Litts inquired as to the status of iPark's taxes. Kevin stated that they are not delinquent, however, they are due. Ulster County Comptroller, March Gallagher, stated that they owe \$1.4 million between school and property tax. Upon further discussion of financials, it was requested that an invitation be extended to Lynne Ward to attend the next UCEDA Board meeting. Brian Cahill suggested that National Resources have an open invitation at the UCEDA meetings until all issues are ironed out including taxes, back payments, mortgage fees and updates on discussions with the County Executive's Office.

 Motion: Herb Litts made a motion to formally invite Lynne Ward/National Resources to the next UCEDA meeting requiring them to provide updates on outstanding financial requirements, obligations, site and tenant updates, seconded by Megan Sperry.

Further discussion surrounding strategic patience vs. tougher accountability was held among Board members and the history of the relationship with National Resources. It was decided that the response and outcome of attendance at the next meeting will

determine the strategy for further actions.

#### PUBLIC COMMENT

March Gallagher, Ulster County Comptroller acknowledged that she is aware that UCEDA is as concerned as she is about iPark and urges the Board to get advice from counsel about what their recourse is. Ulster County Comptroller Gallagher mentioned that iPark is not three years behind in their taxes, so the property is not going to be taken for taxes, UCEDA gave forbearance on the mortgage, so they do not owe mortgage payments right now. The Ulster County Comptroller urges Kevin as President to speak to the County Attorney to see if there is any potential recourse. The Ulster County Comptroller is hearing that they are not being responsive to potential leads which tells her that this property is a big burden to them and that we are not the only ones feeling the pinch from them. If we break the relationship with them, we actually have no recourse, we'll be stuck with nothing happening there and BOCES being very jeopardized.
