corrections to be made.

Draft of Amended 2022 Form 990, 990-T and NY CT-13

Discussion was held around a 2022 990-T when there was confusion around filing as a storage unit vs storage space when UHY prepared the audit. Business taxes were paid for 2022 when it was mistakenly filed as storage unit. Charles Dinstuhl, Deputy Comptroller had noted previously that UCEDA should recoup those taxes. EFPR has prepared these documents for that to occur. UCEDA is eligible to receive approximately \$7,545.00 in federal and approximately \$3,143.00 for state

taxes, totaling \$10,688.00. Estimated cost for this filing is \$600.00.
