#### **Audit Committee Recommendation of 2024 990 Draft**

Gregory Simpson noted that the UCEDA Audit Committee met just prior to this meeting to review the 2024 990 Draft. Chris Jaros reviewed the 2024 990 Draft with the full

Board. The 2204 990 is an informational return, prepared by EFPR which is the same firm that prepares the Audit. Data presented from the audit is consistent with the prior year and is an improvement. No significant findings or corrections to be made.

## Draft Amended 2022 Form 990, 990-T and NY CT-13

Chris Jaros additionally reviewed 2022 Form 990, 990-T and NY CT-13. In 2022 UHY prepared UCEDA's tax filing as having a storage unit instead of storage space. Business taxes were paid in 2022 because of this mistaken filing. Charles Dinstuhl, Deputy Comptroller had noted previously that UCEDA should recoup those taxes. EFPR has prepared these documents for that to occur. UCEDA is eligible to receive approximately \$7,545.00 in federal and approximately \$3,143.00 for state taxes, totaling \$10,688.00. Estimated cost for this filing is \$600.00.

Kevin is scheduled to meet with a representative from Bonadio & Co. to look further into what these LDCs offer.
